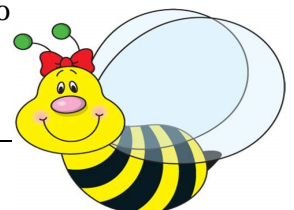


My First Meeting

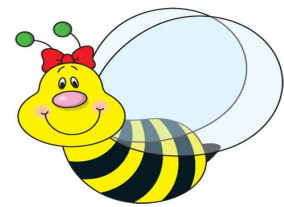
Thank you for asking me to write this. It has brought back sweet memories of my dear Sponsor, Eleanor.

Blast from the Past—My First Meeting

I was married to my second husband but he had not found recovery yet. He ended up divorcing me for another woman he had met in the program. I eventually married again, not an alcoholic but a work alcoholic. My program friends supported me in that meeting. When he came down with Alzheimer's, program friends supported me. When I went through my third divorce, again my program friends were supportive. I'm so grateful I had program.

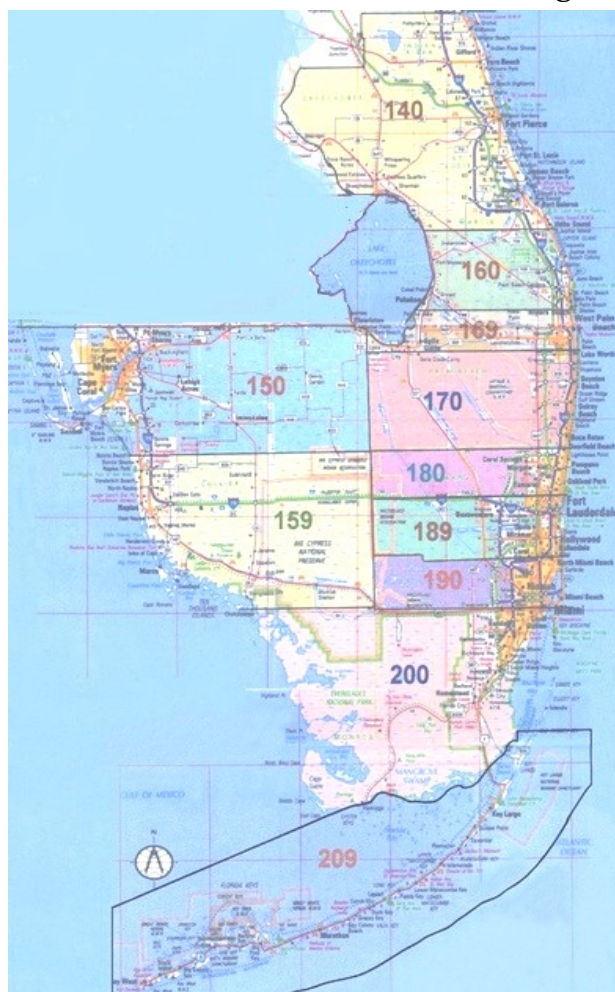
